DINOSAURS:

CARBON-14, or ¹⁴C DATING:

Carbon dating is used to work out the age of organic material - in effect, any living thing. The technique hinges on carbon-14 (¹⁴C) radioactive dating, which is applicable only to matter, presumed to be in balance with today's atmosphere, and was taking in carbon dioxide from the air for photosynthesis. With the waters above the firmament, the ¹⁴C radio carbon atoms would have been missing or barely present in the biosphere and in living organisms. The less ¹⁴C is found in a fossil, the older it is estimated to be. Hence, the fossils from before the flood will date much older than they really are as they have practically no traces of ¹⁴C.



MOUNT EVEREST AND 'THE GREAT DIVIDE'

In 1953 Sir Edmund Hillary and Tenzing Norgay climbed Mount Everest of 29,030 feet, or 8848 meters high. When they got up to the altitude of 26,000 feet, or 7924



meters, they began to find sea shells. That is 3030 feet, or 924 meters, from the summit. How's that possible; did mussels climb mountains, or were the Himalayas much lower during the Flood, before the great divide of the tectonic plates' movement?

'Unto Eber were born two sons: one Peleg (meaning division); for in his days (his birth 101 years after the Flood) was the earth divided;' (Gen.10:25) The different areas **already had some population** on them before the Great Divide, so diverse peoples can look similar.

Seashells are found on many mountains, as the Flood waves deposited seashells and mud on the mountain bases. Mount Everest was during the flood only 924 metres or 3,030 feet high, as 29,030 feet minus 26,000 is 3,030 feet. Therefore from 26,000 feet upwards is where the shells are found. Then during the great continental divide and the collision of the Indo-Australian tectonic plate with the Eurasian plate, the Himalayas were pushed to a much higher altitude and Mount Everest rose by 26,000 feet. Hence, no seashells below 26,000 feet.

The shifting of tectonic plates and the moving of the continents was a tremendous upheaval, with

whole cities and regions like Atlantis; pyramids, temples, and structures sliding underwater. We find them everywhere; off the coasts of Greece, Portugal, Japan, Italy, Cuba, South America, etc., etc.

This enormous pyramid is near Yonaguni, Japan. The size of the blocks shows that it was pre-diluvian, or from before the flood, as in those days there were 'giants in the land' who were able to assist in moving these enormous stone blocks into place.

Professor Masaki Kimura (geologist at Ryukyu University in Okinawa) "This could only have been done by a people with a high degree of technology... to have created such a huge structure."

The Great Flood



THE GREENHOUSE EFFECT BEFORE THE FLOOD

The Lord said: 'I made the firmament, and divided the waters which were under the firmament from the waters which were above the firmament:' (Gen.1:6,7) and there were 'the fountains of the deep'. (Gen.8:2) The waters above the firmament were a canopy that gave a greenhouse effect on the Earth. It shielded the Earth and those living on it from the cosmic radiation, the damaging UV and Carbon-14 rays. Before the flood the sun and moon were not clearly visible, as their light was filtered by this water/ice layer. The sun and moon are referred to back then as, 'the greater light to rule the day, and the lesser light to rule the night:' (Gen.1:16) They are only mentioned by name after the Flood.

The weight of the protective translucent water layer **increased the oxygen** level by more than half. This gave an amazing **huge sub-tropical Flora and Fauna**; of the flora we still find proof in Arctic regions and the coalmines worldwide.

After the flood, the oxygen level dropped from 35% to 21%.
